Adult version of the protective footwear for motorcycles riders model "Boot 3.5" provided in the following sizes: 40.5-42-43-44.5-45.5-47-48 (European sizes) or 7-8-9-10-11-12-13 (United States sizes); junior version provided in the following sizes: 33-34-35.5-37-38-39 (European sizes) or 1-2-3-4-5-6 (United States sizes). The device is closed in the lateral part by means of buckles and a Velcro strap. For both adult and junior versions, upper made by PU microfiber and plastic reinforcements, lining made by textile mesh + foam, adjusting buckles made by S.S. AISI 304, TPU, Delrin and PA66, outsole made by vulcanized rubber; insole made PP (code PPAI) and insock made by textile mesh + EVA (code MDFEVA). Junior version differs from adult one, in addition to dimensions and colour, also for some construction features. These footwear are specifically designed for motorcycle and motocross activities. The present EU Type-Examination Certificate is the third revision of the previous one issued by Dolomiticert Scarl in date 17/09/2021 with number EC 21-0174. The present revision considers the introduction of two new variants (Jr Stealth and Jr White) and the updating of some plastic components for junior versions.


