The garment offers limited protection against mechanical risks arising from impact and abrasion in case of a fall while participating in motorcycling activities.

This PPE item has reached the following performance:

Class AA(\*): Class AA garments offer protection from impact and abrasion against the risks of the greatest diversity of riding activities and may have lower ergonomic and weight penalties than Class AAA garments.

(\*): The Standard provides different classes of protection for garments including protectors/shells: AAA (highest class), AA (middle class) and A (lowest class); class B is for garments not including protectors / shells = just abrasion protection; class C is for impact protector ensemble garments.

NOTES: the protection provided also depends on the correct fit of the garment; the CE-Certified incorporated impact protectors provide strengthened protection and must be kept in their place: this falls within the responsibility of the user.


